# **Works in Progress:**

Manuscript: *Mexican Catholic Women's Activism*, 1929-1940. Proposal submitted to the University of New Mexico Press, February 2008.

This book-length work examines Catholic lay women's roles in the Church-State conflict in Revolutionary Mexico. After the Cristero Rebellion (1926-1929), clergy and laymen who publicly supported the Catholic Church were threatened with legal sanctions and government reprisal. Thus, Church leaders called upon women to assume public roles and to work creatively in defense of their faith, albeit following strictly delineated, gendered norms of behavior. In doing so, these women both reinforced and challenged roles proscribed in their society, and laid a foundation for their increased participation in conservative and liberal religious, social, and political organizations.

The first, introductory chapter presents rationales for studying these women and for choosing the Archdiocese of Guadalajara and the state of Jalisco as a case study; it also includes a review of existing histories of Mexico's armed revolution and religious conflict, of regional studies as part of Mexican historiography, and of feminist reexaminations of both Catholic and Mexican history. Chapter 2 traces the history of Catholic Social Action as envisioned in Europe and as translated and adapted to Mexico, from the end of the nineteenth century through the Cristero Rebellion, and includes an overview of Catholic women's activism prior to 1929. Chapter 3 presents the reorganization of various Catholic lay women's social and civic associations into the Unión Femenina Católica Mexicana (UFCM) and their contributions to the ACM on a national level. Following these, a longer section more fully treats the Archdiocese of Guadalajara and the state of Jalisco as a case study of these social and cultural contests: Chapter 4 introduces the region and antecedents of Catholic activism and women's participation there; Chapter 5 examines "The Politics of Religious Life," including women's challenges to laws restricting the use of public space for religious displays as well as their support for the women and men religious targeted by federal and state anticlerical legislation; Chapter 6 examines the social debates and activist campaigns regarding education, particularly Mexico's experiment with "socialist education"; Chapter 7 examines "Women and Work," exploring the tensions between religious rhetoric that glorified women's place in the home and the realities of women who needed and wanted to engage in both salaried and volunteer work, as well as women's perceptions of the struggles over labor and land reform law during the 1930s. The volume concludes with an eighth chapter that evaluates the long-term impact of these women's mobilizations.
